3 Chairman's Report for the year to 31 March 2018

3.1 Chairman reported on his year of office considering policies, especially Grants Policy and recently General Data Protection Regulations. Proportional representation had been considered, but not altered. Highways Issues were a concern, the responsibility of Lancashire County Council, without progress. Coach and Horses had re-opened, but Dog & Partridge had closed. Councillors had attended a training event, and grants had been given to each Village Hall and to the setting up of the Heritage Trail. The Neighbourhood Plan had been withdrawn and its Steering Group disbanded. An Information Commission complaint had been dealt with. The stolen defibrillator had been replaced and donation and promise may allow for a further one in the Parish. Wreaths had been placed at each War Memorial; lighting in Tosside near the church had received support. Parish Lengthsman's work was much appreciated, for the routine jobs, but also the additional. He then expressed particular thanks to Borough Cllrs. Sherras & Elms for all of their input, to Vice Chairman Clements, to Cllr. Willock for the website, to Parish Clerk for her efforts, but in particular to all members for pulling forwards together.

4. To consider and approve policy for future term of office for the Chairman

4.1 Clerk explained that this item had been approved at 2017 Annual Parish Council Meeting, but for Standing Order changes, confirmation of resolution was needed the following year It was then

RESOLVED unanimously - that Chairman may in future serve a term of office of up to three years consecutively, but not seek re-election for a further three years, and that Standing Orders be amended to reflect this change.
