2.1 The Minutes of the Parish Council Meeting held on 1<sup>st</sup> July 2019 had been circulated and it was **RESOLVED that those Minutes be accepted and approved**

4.1 Several residents present expressed views regarding the planning application 3/2019/0588 at Holden Clough Nursery, detailing their concerns

4.2 The applicant for Planning Application 3/2019/0588 addressed the meeting, passed round the plans and answered a number of gueries from both residents and Parish Councillors

#### 5 <u>To consider and approve any actions to be taken regarding Planning Applications</u>

• <u>3/2019/0588 - Holden Clough Nursery - Change of use of agricultural land to parking and landscaping. Two</u> poly tunnels and stone service area.

5.1 Members discussed the application in detail, noting that the work had started prior to submission of the application. Residents' concerns were taken into account and members noted that the business was a successful enterprise in a hamlet location. It was then

RESOLVED that a letter expressing Parish Council comments be drafted by Clerk for approval by Councillors before submission to Ribble Valley Officers. The letter was to make particular reference to Area of Outstanding Natural Beauty, the layout of the proposed car parking and Council's concerns regarding traffic and its management, asking that LCC Highways officers visit the site, also noting the expected disturbance to residents in Holden.

• <u>3/2019/0544 - Ghyll Seeds Farm, Knotts Lane - Retention of two caravans to be used as one dwelling for a temporary period.</u>

5.2 This application was discussed, members noting that the application was to regularise the retention of the caravans, however no objection was to be submitted to Ribble Valley Planning Department.
